Consultation Survey Results

What is the survey?

The Consultation Coordinator has delivered a questionnaire to community members to understand their current views on the Duty to Consult, Aboriginal Rights and Treaties, community priorities and goals, moving forward from goals and achieving goals, how to engage community members. This will be used on how/what the Resource Development Consultatio Coordinator will share with community members.

Results

We had a total of 36 community members complete the questionnaire. Out of

those participants, 16 were female, 17 were male and 3 were unspecifed. Out of the applicants, 2were at the age of 18-30, 13 of 31-50 and 21of 50+. 33 were on reserve and 3 were off reserve.

The questionnaire resulted in 35 out of the 36 partipants stated they would like to learn about the rights to hunt, fish, trap, and gather. Importance for community meetings was to be in the evenings and provide reminders.

The winner of the \$25 visa gift card was Richard Francis Sr. (Jackie). Thank you to all the participants and providing your feedback.

Scotian Basin Drilling Exploration Proposed Project

In the "Resource Development Newsletter for January 2016", explains clearly what the Scotian Basin Drilling Exploration proposed project is.

The Proponent's name for the Scotian Basin Project is British Petroleum. BP is the world's leading international oil and gas companies. BP provide customers with fuel

for transportation, energy for heat and light, lubricants to keep engines moving, and the petrochemicals products used to make everyday items as diverse as paints, clothes and packaging. www.bp.com

In November 2015, Kingsclear applied for Particpant Funding from the Canadian Environmental Assessment Agency (CEAA). The funding is

allocated for a scientific technical review on how the project can potentially impact our rights to fish, legal to review any documents, and admin costs used to disburse information on the project.

Kingsclear has had one face to face meeting in WFN on October 20th, 2015 with the proponent and one confernce call with the proponent to date.

Sisson Mine Proposed Project Update

On Wednesday February 3rd, 2016, Kingsclear received the Federal Draft Comprehensive Study Report (CSR) from the Canadian Environmental Assessment Agency (CEAA). This document is 128 pages of the technical review on the Sisson Mine bu the federal government. Sarah Hechtenthal from MSES will be reviewing the document on behalf of the Maliseet Nation. The First Nation comments are to be submitted by February 24th, 2016. Within that time frame, the Consultation Coordinator will be collecting letters from active land users to submit to CEAA to demonstrate KFN's use of the proposed mine area. The federal

government will probably decide whether to approve the Mine this summer. New Brunswick already issued its main approval, on December 3rd, 2015.



On Monday January 11th, 2016, KFN had a community meeting w. legal, Dominique Nouvet & technical support, Sarah Hechtenthal. There was a total of 24 members.

Archeological Field Technician Level 1 Program

Partnership between NBCC, CCNB, PETL and Arch Services (THC)

What is the Archeological Field Technician Level 1 program?

Occupational training programs for archaeological field technicians are not currently available in New Brunswick. In recognition of this need, Post-Secondary, Education, Training and Labor (PETL) developed a 14-week training program. The training is a 14-week certified program through NBCC and CCNB. The program is designed to provide learners with the skills to work as a technician on an archaeological dig. They learn relevant theory and the practical skills required to process with

artifacts from archaeological excavations, re-pack collections, keep records of work, and organize documentation to be entered into a database.

The training started on Monday February 15th, 2016 in Fredericton, NB.

This course will combine lab work, group work, site visits, guest speakers and some classroom theory teaching. The course has 60 students with lecture style teachings combining practicum experience with theory.

TransCanada Energy East Proposed Pipeline

TransCanada Energy East
Proposed pipeline will cross a total
of 961 waterways. 281 waterways
will potentially be crossed in New
Brunswick. Some of the waterways
are Madawaska, Tobique,
Canaan, Kennebecasis – all major
tributaries of the St. John River –
and the Cains and Southwest
Branch of the Miramichi, just to
name a few.

Stantec has the master environmental contract for work on the pipeline. Previously Stantec has sub-contracted through Green Eagle to employ several indigenous workers. In 2015 they employed four field workers for

phase 1 (environmental surveying) running from July through September. In phase 2 (archaeological surveying) they employed ten field workers, six observers and one Indigenous archaeologist. This phase ran from October to December 2015. These workers came from a variety of First Nation. All workers were hired through a merit based screening process.

What is the National Energy Board (NEB)

The National Energy Board (NEB) is an independent regulatory body responsible for international or inter-provincial regulations of oil, gas, and electricity industries in Canada. The NEB will not have the final decision on whether to approve the pipeline. Instead, the NEB will review the pipeline and recommend to the Lieutenant Governor in Canada whether to approve the pipeline and on what conditions. The NEB will do an environmental assessment as part of their review.

Kingsclear First Nation is currently registered with the NEB with an Aboriginal intervenor. This means that to KFN can actively participate in the NEB hearing and provide oral and written evidence to the NEB.

Not much has been made known about the NEB hearing process to date. Energy East has filed its application amendments and the NEB has not yet found it complete. Once the NEB announces the application is complete, it will

also give more information on the hearing process.

What is the NEB hearing?

NEB hearings are public processes. This means that any person or group with an interest in a proposed project may ask to participate in the NEB process related to that project. The NEB encourages potentially impacted Aboriginal groups to participate in the review process for the project. The NEB requires companies to consult with potentially impacted Aboriginal groups early in the project planning and design phases, when it is easiest for the company to respond to concerns raised by Aboriginal groups.

Kingsclear Engagement:


Since the open house in August 2015, Kingsclear has not held any futher open houses with the proponent (NB Power).

NB Power- Wolastoqiyik Consultation Protocol

What is the Wolastoqiyik Consultation Protocol?

The Wolastoqiyik First Nations are preparing to consult with NB Power on various issues related to developments within Wolastoqiyik territory, re: the future of the Mactaquac Generating Station.

The consultation protocol is made up of all six Maliseet communities; Ocomocto, St. Mary's, Kingsclear, Woodstock, Tobique and Madawaska Maliseet First Nations.

NB Power wishes to consult with us on the future of the Mactaquac Generating Station and we need to prepare to consult with them on these developments as they fall in our territory. Before we do that, we need to figure out what protocols need to be in place between our communities and within each of our communities. We also need to determine how we will consult with NB Power.

It is essential that you as community members have input on those protocols and things that need to be taken into consideration.

There is two phases for the consultation protocol.
