Mactaquac Dam Project

Project information

NB Power is currently exploring 3 options for the Mactaquac Dam (building a new powerhouse, retain the headpond (no power) or river restoration), as the dam is expected to end its service life in 2030. Mactaquac is 1 of 7 hydro stations in NB and has a generating capacity of 668 MW (supplies approx. 12% of the province's energy needs).

Technical Lead

NB Power has released a Comparative Environmental Review (CER) drafted by Stantec. The Maliseet will make comments on the document with the help our technical reviewers MSES (who also work with the Maliseet communities on Sisson and

TransCanada).

First Nation Engagement

Kingsclear has hired a Survery Researcher, Cyril Sacobie for eight weeks to work on the Mactaguac file. The purpose of this position is to collect input from Kingsclear community members, both on and off reserve, on the Mactaguac Generating Station project for NB Power.

TransCanada Energy East Proposed Pipeline (EEP)

The EEP is a proposed 4600 km pipeline which will transport Alberta and Saskatchewan crude oil from Hardisty Alberta to Saint John New Brunswick.

The pipeline is expected to go through the traditional territory of 180 different Indigenous communities.

The pipeline has undergone several changes and re-routes since its inception. With nearly 700 re-routes along its complete course with 53 reported route alterations in New Brunswick alone. These come about due to an unacceptable level of environmental and socio-economic risks. For TransCanada to make the proposed pipeline into a reality they must pass a National Energy Board (NEB) review and then get approved by the cabinet of ministers of Canada. To pass the NEB they must submit a Environmental and Socio-economic Assessment (ESA) which includes several criteria or valued components (VC). They are as follows:

- Atmospheric Environment
- Acoustic Environment
- Surface Water Resources
- Groundwater Resources
- Fish and Fish Habitat

- · Soils and Terrain
- · Vegetation and Wetlands
- Wildlife and Wildlife Habitat


The above is the environmental aspect, but they also include human considerations:

- · Human Occupancy and Resource Use
- Heritage Resources
- Palaeontological Resources
- · Traditional Land and Resource Use
- · Employment and Economy
- Infrastructure and Services
- Social and Cultural Well-being
- · Human Health
- Visual Aesthetics

Currently the EEP is in the process of filing a consolidated application to the NEB. Kingsclear First Nation is listed as an Aboriginal Intervenor for this process which means our representatives will be able to table our interests and any unrest we feel as a community at the hearings.

The results for the Traditional Use Study will be presented in early June 2016 in Kingsclear by the Maliseet's consultant Peter Armitage (Wolverine & Associates Inc.). It is also expected that our technical experts will be presenting on the project in June.

Sisson Open Pit proposed Mine

The federal government (Canadian Environmental Assessment Agency or "CEAA") released their draft Comprehensive Study Review (CSR) to the Maliseet, Mi'gmaq and the proponent on February 3rd, 2016. The draft CSR did not include a significance determination on the project. Comments on the draft CSR (prepared by MSES- Technical lead) were sent to CEAA for their consideration on February 24th. 2016. The revised CSR is set to be released ion April 15th, 2016. CEAA is still accepting comments while they work on the revised CSR. The decision to approve/disapprove of the mine will likely come in late July or early August 2016. The decision is made by the Minister of Environment

and Climate Change of Canada. The project can not go through without federal approval (which the provincial approval was granted in December 2015, subject to 40 conditions).
